- JEF-Wellsburg Bridge Park- N- Ride award date delayed until 2023 due to Ohio River Bridge project delays.
- Greg Gurney LPA coordinator retired at the end of August. Dan Lorenz will take over his position.

Chris Kinsey from WVDOH reported that Long Range Transportation Plan completion date June 30, 2021. WVDOH will hold four stakeholder meetings that will involve the MPO's to provide input or guidance during these meetings. First meeting should be in the beginning or middle of October.

Mike Witherow reported that Harmon Creek bridge and Gas Valley Road projects have been completed. Ongoing work with Wellsburg Bridge, Long Run Bridge, and WV 8 North of New Cumberland. Upcoming paving projects on Route 2 north of Weirton, Wellsburg 12th street to 27th street, portion of Gentile Ridge, Congo Run Road, and some various slip repair projects.

THE BROOKE-HANCOCK-JEFFERSON METROPOLITAN PLANNING COMMISSION APPROVING SUPPORT OF ESTABLISHED OHIO AND WEST VIRGINIA STATEWIDE SAFETY PERFORMANCE MEASURES

- **WHEREAS**, the Policy Committee is the Brooke-Hancock-Jefferson Metropolitan Planning Commission (MPO); and
- whereas, per Federal Rule 23 CFR 490 States are required to establish targets for five safety performance measures applicable to all public roads, as the number of fatalities, number of serious injuries, fatality rate, serious injury rate, and number of non-motorized fatalities and serious injuries; and
- WHEREAS, the performance measures are being required to foster transparency and accountability, and help track safety progress at regional, state, and national levels;
- whereas, the Ohio Department of Transportation has established a statewide 2% annual reduction target across all five performance measures which translates as the following numeric statewide targets for 2021: 1,084 fatalities, 8,101 serious injuries, 0.93 fatality rate, 6.97 serious injury rate, and 811 non-motorized fatalities and serious injuries; and
- whereas, the West Virginia Division of Highways has established a statewide target to reduce fatalities and serious injuries by 50% and 66%, respectively, by the year 2030 and for 2021 has established the following numeric statewide targets: 274.2 fatalities, 1,123.5 serious injuries, 1.470 fatality rate, 5.6.29 serious injury rate, and 91.6 non-motorized fatalities and serious injuries; and
- **WHEREAS,** Metropolitan Planning Organizations must establish targets for their respective areas within 180 days of State's establishment of targets; and
- WHEREAS, the Policy Committee has analyzed and determined that it will support the established Ohio Department of Transportation's statewide safety targets in Jefferson County; and
- WHEREAS, the Policy Committee has analyzed and determined that it will support the established West Virginia of Highway's safety targets in Brooke and Hancock Counties; and

WHEREAS, the Brooke-Hancock-Jefferson Metropolitan Planning Commission (MPO) does hereby agree to plan and program projects so that they contribute toward the accomplishment of the Ohio Department of Transportation's state safety targets for Jefferson County, Ohio and the West Virginia Division of Highway's state safety targets for Brooke and Hancock Counties, West Virginia;

NOW THEREFORE BE IT RESOLVED: that the Brooke-Hancock-Jefferson Transportation Metropolitan Planning Commission does hereby support the Ohio state targets for Jefferson County, Ohio, and the West Virginia state targets for Brooke and Hancock Counties, West Virginia.

WHEREAS, Revision #2 includes the addition and modification of the following projects:

As identified in federal regulations, projects not considered to be of appropriate scale for individual identification may be grouped by function, work type, and/or geographic area in the TIP. ODOT or BHJ may add a project to the SLI Grouped Project List by administrative modification in a given program year if the projects scale is not appropriate for the individual project list and has the characteristics as identified in **Table 6**. BHJ has amended the TIP to include BHJ funds in the MPO Capital SLI Group to allow for additional flexibility and to help streamline the process for projects that meet the SLI Group Project guidelines and have approved BHJ funds. The amount of funding for the MPO Capital SLI Group will be determined by the MPO and included in the TIP and STIP by program year. The amount included in the MPO Capital SLI Group is included in BHJ's reasonable fiscal constraint. Fiscal Constraint for all SLI Groups is maintained at a statewide level in the STIP.

BHJ may choose to add projects to the TIP using the MPO Capital SLI Group where the projects meet the SLI Group Project guidelines and come from the following programs.

Assisting Local Programs

These projects may be used when assisting localities in paying for the costs associated with the funding match that is required in some state granted funding. This funding will cover the local match that is required for certain funding as well as the costs that can occur that the applied for funding does not cover, that the localities are responsible for.

Safety Signage Program

These projects may be used to assist in funding or fund entirely, signage on township, village, or city roadways that is intended to increase the safety of the given roadway. This is based on the ODOT program, Safety Funding Signage Program, to upgrade existing or install additional safety signage.

Guardrail Improvement Program

These projects may be used in funding the replacement of existing or installing additional guardrail where deemed necessary through crash reports and/or physical condition of existing guardrail, to improve the safety of the roadway on township, village, and city roads.

Dear Mayor Barilla:

The Ohio Department of Transportation is proposing to resurface State Route 43 from State Route 7 to 5th Street, and from Belleview to Welday Avenue within the City of Steubenville in the summer of 2022. Since this project is within the corporation limits of the City, it will be necessary that we obtain legislation from the City. Attached is a copy of an ordinance which shall require action by City Council. The work on the project will include pavement planing, asphalt resurfacing, guardrail replacement, striping and curb ramps. Our district estimate for the City share of the project is \$419,282. The 100% City items are estimated at \$241,457 and the remainder is the 20% share of the resurfacing work. An official state estimate will be calculated approximately 2 months before the project sale date (February of 2022) and you will receive final participatory legislation using those costs.

In completing the attached legislation, please be sure to indicate the Ordinance No. and Date of Enactments in the upper right hand corner of Page 1. You will note in Section VI, the Mayor has been designated as Contractual Officer. Your signature must appear on Page 3 in the space provided for Contractual Officer as well as in the space on Page 2 for Mayor's signature. Both should be attested to by a Councilman or the Clerk. If the City has no President of Council, please write the word "SAME" in quotes in that space indicating the Mayor acts as President of Council. Also on Page 3 in the "Certificate of Copy", please be sure to fill in Ordinance Record No. and Page. If the clerk has a seal, it should be affixed to the "Certificate of Copy". If there is no seal, a letter stating that the City does not have a seal should accompany the executed legislation.

When the legislation has been properly executed and all signatures affixed, please return a signed copy to me. Please mail an original copy to my attention at the ODOT District 11 address listed above. After a copy has been signed by the Director of the Ohio Department of Transportation, a copy will be returned to the City. Please return the executed legislation to our office by December 15, 2020 so that it can be forwarded to Columbus.
